## Information

### 1. Raw Air Tournament rules 2025

#### Men

The competitions in FIS World Cup RAW AIR are all organized according to the FIS competition rules and World Cup rules as single events, in addition to the individual overall Tournament.

Points for the overall Tournament will be gained from the two destinations:

#### Raw Air Finale

- Reduction after qualification to 30 athletes.
- 1<sup>st</sup> round 30 athletes
- 2<sup>nd</sup> round 20 athletes
- 3<sup>rd</sup> round and finale are 10 athletes.

#### Starting order

- **Qualification in Oslo:** Reverse order of WC ranking.
- **All other competition in Raw Air:** Reverse order of current RAW AIR ranking in qualifications and first round. Reverse order of first round in second round.
- **RAW AIR Finals on Sunday**
  - Qualification: Reverse order of the current RAW AIR standing after Saturday's competition.
  - 1<sup>st</sup> round: Reversed order of the current RAW AIR standing after Saturday's competition, those athletes not qualified are taken out.
  - 2<sup>nd</sup> round: Daily reversed order after first jump.
  - 3<sup>rd</sup> round: Daily reversed order after second jump.



## Women

The competitions in FIS World Cup RAW AIR are all organized by the FIS competition rules and World Cup rules as single events, in addition to the individual overall Tournament.

Points for the overall Tournament will be gained from the two destinations:

- Standard World Cup rules for Oslo (registration for qualification according to quotas pr. NSA. 40 athletes qualify for the competition).
- Athletes\* qualified for Vikersund are:
  - competitors, who is ranked Top 25 of World Cup standing after Oslo.
- The starting order for the Official Training will be the World Cup ranking in reverse order. The starting list for the first competition will be prepared according to the ranking of the official training result. The starting list of the second competition will be in reverse order of the ranking of the first competition.

*\* athletes who have already reached 18 years of age by the first official training day*

## 2.1 Accreditation

The accreditations will be approved according to the registrations in the FIS Entry. Those who have the FIS season accreditation can use this instead of the local accreditation. All teams will get accreditation cards at the first TCM in Oslo. Accreditation cards for FIS Officials, FIS M&M, Infront, ST Sport service and SRS Industry will be handed out at the event office at each destination.

### 4.1 Accommodation rules

The Organizing Committees at each destination will cover accommodation inside quota and within the competition period according to the FIS Rules 6.2.1.

In case of late cancellation and for booked room reservations not used the team will be charged. The cancellation fee is 100% between 8 days and until the end of the events, and for changes of more than stated in the FIS rules.

## 4.3 Accommodation costs

For additional persons or additional nights (above the quota) the price per person per night with full board is:

Double room: CHF 125

Single room: CHF 160

For nations with a starting quota of 4 or more, the OC will cover two single rooms. In the case of extra single rooms inside the quota, the cost difference between single and double rooms must be paid. However, in cases where single rooms will be necessary because of gender, role, and number of athletes and staff inside the quota the OC will cover this.

The OC cannot guarantee extra rooms that are not included in the entries.

## 5. Transport

### 5.1 Official airport

Oslo Airport, Gardermoen

Arrival Oslo Airport: The LOC in Oslo will organize transportation from the airport to the hotels.

Departure Oslo Airport: The LOC in Vikersund will organize transportation from the hotels to the airport.

The LOC will organize one free transportation per team from the airport of arrival to the first venue and from the last venue to the airport.

### 5.2 Schedule, bus

The times for the buses will leave for Drammen directly after the competition in Holmenkollen.

#### 5.4 Prices for transport of luggage

Trondheim – Oslo – Vikersund: CHF 50 pr. piece.

The price include:

- Transport of equipment from waxing room in Trondheim to waxing room in Oslo.
- Transport of equipment from waxing room in Oslo to waxing room in Vikersund.

More information will be provided at the TCM in Trondheim.

Booking of ground transportation for equipment must be done through [THIS FORM](#) before the 1<sup>st</sup> of March. The booking is non-refundable but can be changed before the deadline.

## 6. Payment/settlement

### 6.1 Travel money and payment

The OC will pay out travel money for the destinations the athletes are participating at (Oslo and Vikersund)

- Travel money will be deducted from accommodation above quota and paid by bank transfer. Please send us updated bank information to [silje.solbakken@olympiaparken.no](mailto:silje.solbakken@olympiaparken.no)
- Accommodation costs above quota: Teams will pay directly in the event office. Only credit cards will be accepted.
- In case you are not able to pay by card, please send us your invoice information in advance.

### 6.2 Reimbursement for FIS Officials

### 6.3 Prize money

Prize Money will be paid by bank transfer to the athletes after the FIS RAW AIR Tournament. The prize money is regulated by the FIS Rules. Receipts will be provided to the athlete electronically and a copy transmitted to FIS.

In addition to the prize money regulated by the FIS WC rules, there will be extra prize money paid to the FIS World Cup RAW AIR Tournament overall top 3 athletes.

	<b>Men</b>	<b>Women</b>
First Prize	€ 30 000	€ 20 000
Second Prize	€ 14 000	€ 10 000
Third Prize	€ 7 000	€ 5 000

This overall prize money also includes the final competition in Vikersund. Men and women do not have the same number of counting rounds, and the prize money are calculated after this.

#### 7. Income tax information for prize money

- The current Norwegian tax rate for non-resident athletes is 15%.
- Income tax of non-European citizens is 15% (USA 0%)
- Due to a special tax convention between Norway and USA, income tax will not be deducted by the OC for income less than USD10000 – “the income shall be taxable only in the State of which the sportsman is a resident”.
- Tax will be deducted by the OC according to the Norwegian *Foreign Artist Taxation Act*, and taxes will be paid by the OC according to the regular tax legislation in Norway.

#### 8. Waxing facilities – location

- Holmenkollen: close to the ski jumping hill – behind the lift lobby
- Vikersund: close to the ski jumping hill – behind the athlete village

There will be no ski-waxing rooms available at the hotels.

#### 9. Regulations regarding radio equipment

The import, export and the operation of radio equipment in Norway is regulated by national law. Permits for the use of radio transmission equipment must be requested according to national specifications. For further information and application form ('Application for temporary use of radios in Norway') see the National Communication Authority: <https://www.nkom.no/english/duty-to-register>

The application must be forwarded before 1 February.

## 10. Visa Regulations
